ALSO, THE DIAPER PROGRAM FOR ADULTS HAS ALSO BEEN EXPANDED INTO TRADITIONAL ASSYRIAN CHRISTIAN AREAS. IN JORDAN A SUMMER CAMP FOR CHRISTIAN CHILDREN HAS BEEN SUPPORTED FOR NEARLY TWO DECADES. AT AN ORPHANAGE IN PLATEAU STATE, NIGERIA, THE WATER SYSTEM WAS REPLACED, AS WELL AS MATTRESSES REPLACED, ROOFS REPLACED, A STATE-OF-THE-ART WATER
