POST COVID-19 THE PROGRAM CONTINUES TO RETURN TO ITS FULL POTENTIAL, GIVING THE OPPORTUNITY FOR CHRISTIAN CHILDREN TO CELEBRATE THE BIRTH OF THE SAVIOR. CHILDREN ENJOY A MULTI-HOUR PROGRAM INCLUDING MUSIC, GAMES, CONTESTS, PUPPET SHOWS, A HOT MEAL AND AGE-APPROPRIATE GIFTS. FAMILIES OF THE CHILDREN RECEIVE AID SUCH AS HYGIENE KITS OR BLANKETS DEPENDING ON THE AREA. IN 2022, PROGRAMS WERE HELD IN SYRIA, IRAQ, JORDAN, LEBANON, AND THE WEST BANK TOWNS OF BETHLEHEM AND BEIT SAHOUR AS WELL AS IN NIGERIA.

YEARS OF WAR IN IRAQ AND SYRIA CAUSED A LACK OF MEDICAL CARE, LEADING TO INCREASED NEED FOR ADULT DIAPERS. THE INFANT PROGRAM HAS BEEN DECREASED BECAUSE OF THE INCREASE IN SPECIAL NEEDS ADULT DIAPER REQUESTS. ADULT DIAPERS ARE CONSIDERABLY MORE EXPENSIVE THAN INFANT DIAPERS BUT HAVE A LIFE CHANGING EFFECT. IN MANY CASES, WITHOUT DIAPERS, ADULTS WOULD HAVE BEEN FORCED TO SLEEP ON THE FLOOR. THE PROGRAM GIVES SPECIAL NEEDS ADULTS DIGNITY.
